** The candidate for motorcycle inspection certification must possess a valid PA Motorcycle operator's license.*

+ The candidate who wishes to add a category to his/her current inspector license will pay only \$55.00 for Cat I or II.

REGISTRATION:

To be registered for the course, you must complete and return:

- ✓ MV 409 form
- ✓ Photo copy of your valid PA Photo ID Operator's License
- ✓ Check or money order made payable to Central Westmoreland CTC. Cash payments may be delivered in person to our office. We do not accept credit or debit cards.

Registration ends **Thursday, April 3, 2025**. Unless other arrangements are made with the office, we must have your completed MV-409, a copy of your driver's license AND payment by this date.

TESTING GUIDELINES

- ✓ You must be familiar with the following tools prior to class:
 - Brake Lining Gauge
 - Brake Drum Micrometer
 - Brake Rotor Gauge
 - Headlight Aimer
 - Ball Joint gauge
- ✓ The Tool Seminar is a basic instruction class with an opportunity to use the tools of the Inspection Procedure.
- ✓ The Tool Seminar does **NOT** take the place of practice.
- ✓ To pass the tactile test, you **MUST** be proficient in the **USE** and **APPLICATION** of the tools.
- ✓ The **Written Baseline Test** will be administered on the fourth evening of class. **A score of 70 % is required to proceed to the Written Category tests.** If the Written Baseline Test is failed, the student may retake the entire course when it is offered again. The fee to re-take the course in this case is reduced to \$80.00.
- ✓ **A score of 70% is required for each Written Category Test in order to be scheduled for the Tactile Exam.** If a Written Category Test is failed, it may be retaken at the next scheduled course offering for a reduced fee of \$25.00.
- ✓ The student will be notified of the Tactile Exam schedule upon the successful completion of the Written Category Test.
- ✓ The Tactile Exam is PASS/FAIL. If the Tactile Exam is failed, it may be retaken at the next scheduled course offering for a reduced fee of \$55.00.

GENERAL INFORMATION

- ✓ Tuition fee includes a copy of *Vehicle Equipment and Inspection Regulations Manual (PUB 45)*. You will receive your Manual on the first night of class. To access PUB 45 online, visit the PennDOT website, www.penndot.gov. Click on Forms, Publications & Maps. Enter **PUB 45** in the Search Bar.
- ✓ Tuition fees are non-refundable once instruction begins.
- ✓ Students must be 18 years-old.
- ✓ Identification will be verified at all classroom and testing sessions.
- ✓ Students must be on time for class and attentive to the proceedings.
- ✓ Students must attend ALL classes. Take notes, participate, and ask questions.
- ✓ Bring a highlighter, notebook, pen and #2 pencil to each class. Safety glasses are required for the tactile exam.
- ✓ This program covers all required program content as per PennDOT requirements.
- ✓ Course dates are subject to change as necessary.
- ✓ Students must adhere to all Central Westmoreland CTC policies.
- ✓ Smoking and the use of tobacco products are not permitted at CWCTC. This includes the school, parking lot, and all premises.

Applicant must be 18 years of age and have a valid operator's license for each class of vehicle they intend to inspect. Applicant must also complete a lecture course at an approved educational facility, pass a written test and satisfactorily perform a complete inspection of a vehicle. Upon successful completion of these courses, you will receive your certified safety inspection certification card in approximately 6 to 8 weeks from the date your class ended. The school has 35 days from the class ending date to submit the paperwork for processing. You may not begin inspecting until you receive your certification card.
