## **GENERAL INFORMATION**

- Students must be 18-years-old.
- Identification will be verified at all classroom and testing sessions.
- A score of 80% is required on the written examination. Those who score less than 80% on the written test may retest but will be required to return at a later date. **Retest fee is \$ 50.00.**
- Out-of-state students: Students who do not have a valid PA Driver's License, but have a valid Out-of-State Driver's License, will be permitted to take the E.I.C. course including exams. However, the MV-501 will not be mailed to the PA Department of Transportation until a valid PA Driver's License is presented to CWCTC. The test scores are valid for up to one year from the date of testing.
- This program covers all required program content as per PennDOT requirements.
- Course dates are subject to change as necessary.
- Fees non-refundable after the start of instruction.
- Students must be on time for class and attentive to the proceedings.
- Students must adhere to all Central Westmoreland CTC policies.
- Class size limited to 20 people.
